## TRACK E2: NATIONAL STANDARDS FOR THE PHYSICAL

INSPECTION OF REAL ESTATE (NSPIRE)

Summary: In 2018 HUD announced its intent to employ widespread changes to the REAC inspection process, and has implemented an avalanche of changes to date, including its 14-day notification procedure. HUD's actions were not spurred by the concerns of housing providers expressed over a decade that the focus on condition and appearance was misplaced, but instead by repeated reports of unsatisfactory housing conditions in the press, Inspector General and Government Accountability Office findings of deficiencies within REAC, and Congressional inquiries into Departmental policies and procedures.

This session will provide an in-depth look into what the Department has announced thus far, the status of the pilot of its proposed inspection protocol, and what's in store for the future of inspections of assisted housing.
